RE: MDOT MVA Branch Offices Set to Reopen on Appointment-Only Basis

The Maryland Department of Transportation Motor Vehicle Administration (MDOT MVA) announced today it will reopen select branch offices to customers on a limited basis beginning **Monday, June 8.**

MDOT MVA will implement several new procedures and guidelines upon reopening to protect the health and safety of employees and customers. These include requiring face coverings, safeguard dividers and social distancing measures. Customers also will be asked a series of screening questions in order to enter a branch.

To reduce foot traffic and limit the number of customers in branch offices at any time upon the reopening, **MDOT MVA will handle customer transactions on an appointment-only basis.** The MDOT MVA Central Scheduling System is not yet available because staff is first contacting customers to reschedule appointments that were canceled during the closure. Once the Central Scheduling System is activated, customers will be able to schedule an appointment online at mvascheduling.mva.maryland.gov.

Reminder – Governor Larry Hogan issued an executive order authorizing an extension of all driver’s and business licenses, identification cards, permits and registrations that expire or are eligible for renewal during the state of emergency. As a result, those documents will not expire until 30 days after the state of emergency has been lifted. MDOT MVA’s reopening does not change this emergency status, it requires an act by the Governor to lift the emergency order.
